#### THE MISSION OF THE OMBUDSPERSON

Legal and constitutional mission of Ombudsperson's Institution (OI) involves protection, monitoring and promotion of human rights and fundamental freedoms from unlawful actions or inactions of the public authorities in Republic of Kosovo. Through these main acting segments the overview of human rights and fundamental freedoms is being established in Kosovo, including the level of their violation.

#### OI WORKING PRINCIPLES

One of the most decisive conditions for social and constitutional functioning of a democratic system is trust and it can be achieved solely if everyone is treated equally in front of the law. Impartiality, confidentiality and professionalism are basic principles of the Ombudsperson's work and respect of these three principles ensures the trust of people in Ombudsperson Institution.

### OI ANNUAL REPORT

The Ombudsperson Institution, as independent institution, determined with the Constitution of the Republic of Kosovo as well as Ombudsperson Law, submits annual report on human rights in Kosovo to the Assembly of Republic of Kosovo. This overview is executive summary of the Annual Report for 2012.



# MOST FREQUENT QUESTIONS ADDRESSED BY CITIZENS

### Who is entitled to submit complaint to the Ombudsperson?

Every natural and legal person claiming that his/her rights or freedoms have been violated by a certain law, illicit action or omission, maladministration by the state bodies, other bodies and organizations exercising public authority on their behalf, may file a request for initiation of the procedure with the Ombudsperson Institution.

## Which complaints are not reviewed by the Ombudsperson?

The Ombudsperson may not review complaints lodged against private persons (apart from those related to allegations for discrimination); complaints against decisions issued by courts, complaints lodged against authorities out of Kosovo, as well as complaints lodged by the applicants who did not exhaust available legal remedies.

## Contacting the Ombudsperson and lodging a complaint?

Every citizen is entitled to lodge a complaint at the central and regional offices of the Ombudsperson Institution as follows:

- In person at one of the OIK offices;
- By filling respective form;
- Via OI urgent phone line (free of charge);
- Via facsimile (by fax);
- Through electronic mail (by e-mail);
- In any other way.





## Investigated cases by OI against responsible authorities


