THE MISSION OF THE OMBUDSPERSON

The Ombudsperson Institution (OI) is an independent institution whose competencies and role are determined by the Constitution of the Republic of Kosovo as well as the Law on Ombudsperson.

Legal and constitutional mission of Ombudsperson's Institution (OI) include *protection*, *monitoring* and *promotion* of human rights and fundamental freedoms from unlawful actions or inactions of public authorities in Republic of Kosovo.

OI WORKING PRINCIPLES

One of the most decisive conditions for social and constitutional functioning of a democratic system is trust and it can be achieved only if everyone is treated equally in front of the law.

Impartiality, confidentiality and *professionalism* are core principles of the Ombudsperson's work and respect of these three principles ensures the trust of people in Ombudsperson Institution.

OI ANNUAL REPORT

OI has constitutional and legal responsibility to submit an Annual Report on human rights situation in Kosovo and activities undertaken by institution to the Assembly of the Republic of Kosovo. This Bulletin is a short summary of 2013Annual Report.

WHAT THE OMBUDSPERSON CAN DO?

- Investigate complaints lodged by any legal or natural person who claims that his/her rights or freedoms have been violated from unlawful actions or inactions or maladministration by the state bodies;
- **4** Investigate cases on own initiative (ex-officio investigation) ;
- **4** Initiate cases in Constitutional Court, in compliance with Constitution and Law;
- Exercises its competences through mediation and reconciliation as well;
- Provide advices and give recommendations regarding compatibility of laws and sublegal acts with acceptable international human rights standards.

WHAT THE OMBUDSPERSON CANNOT DO?

Replace courts; investigate crimes; change courts' decisions or intrude into their work, apart from unreasonable delays or obvious misuse of power.

Review complaints against private persons (apart from those allegations based on discrimination)

Represent parties in Courts or provide legal advices in compiling complaints or other case files.

unvestigate complaints against foreign authorities but can offer good services to the parties.

Investigate complaints, in cases when parties did not exhaust or are in use of effective legal remedies.





Complaints lodged with the OIK against responsible authorities during 2013




Investigated cases from OI against responsible authorities (from case number investigated)

PUBLIC RELATION THROUGH MEDIA AND PUBLIC PRESENTATIONS

128 public presentations (not calculating further dissemination) mainly of Ombudsperson himself as a response to media and journalists' request for statements and interviews, on air programs open to citizens' questions, debates etc. through traditional media forms, electronic portals and written press.

50 statements, notifications, photo news, responses, reports etc. posted on OI web page, through OI profile and page, Facebook, as well as disseminated to media through e/mail addresses.

13 round tables were organized by OI (where public institution representatives in local and central level participated as well as NGOs, media, businesses etc., depending on the themes discussed):

- 8 round tables where OI regional offices are located ;
- 4 thematic round tables in Pishtina, as well as
- 1 round table on occasion of marking the 13 anniversary of OI establishment.

INTERNATIONAL COOPERATION

OI is the only national institution on human rights in Kosovo. As such, it is committed for exchange of international professional experiences and engagement of Kosovo in international bodies of human rights.

OI is member of the following international bodies:

International Ombudsman Institute (IOI), which offers support for member institutions in three aspects: trainings, researches and assistance on global and regional projects.

European Ombudsman Institute (EOI) that is a regional organisation of European Ombudsman, engaged on promotion of Ombudsman concept as institution, exchange of experience in local, regional and international level as well as scientific researches regarding Ombudsman institutions.

European Network of National Institutions for Human Rights (ENNHRI), whose mission is support and empowerment of National Institutions for Human Rights (IKDNJ), to be in compliance with Paris Principles as well as coordination of cooperation between members of ENNHRI- and other regional mechanisms.
